**\*PLEASE READ CAREFULLY\***

These instructions must be followed exactly in order to obtain a marriage license where one spouse cannot be present at the time of application. **This form is for the absent spouse only.**

1. All personal data, **except signature**, must be completed in ink before the document is notarized.
2. This form **must be signed in the presence of a notary**, who will verify the identity of the person signing.
3. The spouse who will appear in person will complete a separate marriage license application.
4. This form **CANNOT** be used for any spouse who is under the age of 18 at the time of signing.
