Dear Voter,

Our records show you're eligible to vote under the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). You can vote in the upcoming election either with the ballot sent to you or by using a federal write-in absentee ballot (FWAB). UOCAVA ballots are sent: 09/20/2024
Last day to request a ballot: 11/04/2024
Postmark deadline: 11/04/2024
General Election Day: 11/05/2024
Election canvass: 11/19/2024

When using a federal write-in absentee ballot, fill out the Voter Information section completely and accurately. Write in the office and candidate name(s) for the races you choose to vote for in the appropriate sections.

Electronic ballots must be received by the Elections Office by 8:00 PM (Mountain Standard Time) on Election Day, Tuesday, November 5, 2024. Mailed ballots must be postmarked no later than the day before Election Day, Monday, November 4, 2024, and received up through the Election Canvass. For more information on the use of the Federal Post Card Application (FPCA), the Federal Voting Assistance Program (fvap.gov), and related deadlines, or the use of a Federal Write-In Absentee Ballot (FWAB) if you do not receive your ballot in time, please contact Utah County Election Division at vote.utahcounty.gov, 801-851-8128, or Elections@UtahCounty.gov.
