REVISED NOTICE OF ELECTION

2022 REGULAR GENERAL ELECTION

I, Deidre M. Henderson, Lieutenant Governor of the State of Utah, in accordance with Utah Code Annotated §20A-5-101, do hereby notify each County Clerk that:

- 1. attached is a list of the offices to be filled at the regular general election to be held in the State of Utah on Tuesday, November 8, 2022;
- 2. attached is a list of filing fees;
- 3. the Declaration of Candidacy filing period for qualified political party candidates begins on Monday, March 7, 2022 and ends at 5:00 p.m., Friday, March 11, 2022;
- 4. the Declaration of Candidacy filing period for local board of education candidates begins on Monday, March 7, 2022 and ends at 5:00 p.m., Friday, March, 11, 2022;
- 5. the Declaration of Candidacy filing period for justices and judges of a court of record begins Friday, July 1, 2022 and ends at 5:00 p.m., Friday, July 15, 2022;
- 6. the Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Monday, January 3, 2022 and ends at 5:00 p.m., Friday, March 11, 2022.
- 7. Qualified political party candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.

1. FEDERAL

- a. U.S. Senate. One (1) Senator for six (6) year term
- b. **U.S. House of Representatives**. One Representative for a two (2) year term in each of the following U.S. Congressional Districts:
 - i. First District. The First Congressional District consists of Box Elder, Cache, Morgan, Rich, Weber, and part of Davis, Salt Lake, Summit Counties.
 - Second District. The Second Congressional District consists of Beaver, Garfield, Iron, Juab, Kane, Millard, Piute, Sevier, Tooele, Washington, Wayne, and parts of Davis and Salt Lake counties.
 - iii. Third District. The Third Congressional District consists of Carbon, Daggett, Duchesne, Emery, Grand, part of Salt Lake, San Juan, part of Summit, Uintah. part of Utah, and Wasatch Counties.
 - iv. Fourth District. The Fourth Congressional District consists of part of Juab, part of Salt Lake, Sanpete, and part of Utah Counties.

2. STATE

- a. **State Executive.** The following position will be elected for a two (2) year term to fill the remainder of a vacancy:
 - i. State Treasurer
- b. **State Senate**. One member for a four (4) year term from each of the following state senate districts:
 - i. District One (1) is located in Box Elder, Cache and Tooele Counties.
 - ii. District Five (5) is located in Davis, Morgan and Weber Counties.
 - iii. District Six (6) is located in Davis County.

- iv. District Seven (7) is located in Davis and Morgan Counties.
- v. District Nine (9) is located in Salt Lake County.
- vi. District Eleven (11) is located in Tooele, Salt Lake and Utah Counties.
- vii. District Twelve (12) is located in Salt Lake County.
- viii. District Thirteen (13) is located in Salt Lake County.
- ix. District Fourteen (14) is located in Salt Lake County.
- x. District Eighteen (18) is located in Salt Lake and Utah Counties.
- xi. District Twenty (20) is located in Daggett, Duchesne, Summit, Uintah and Wasatch Counties.
- xii. District Twenty-one (21) is located in Utah County.
- xiii. District Twenty-eight (28) is located in Beaver, Iron, Juab, Millard and Washington Counties.
- c. **State House of Representatives**. One member of the Utah House of Representatives for a two (2) year term from each of the seventy-five (75) state legislative districts.
- d. **State Board of Education.** One member for a four (4) year term from each of the following State School Districts:
 - i. District One (1) is located in Box Elder, Cache, Morgan, Rich and Summit Counties.
 - ii. District Two (2) is located in Weber County.
 - iii. District Four (4) is located in Davis and Salt Lake Counties.
 - iv. District Five (5) is located in Salt Lake County.
 - v. (Tentative) District Six (6) is located in Salt Lake and Summit Counties.
 - vi. District Eight (8) is located in Salt Lake County.
 - vii. District Eleven (11) is located in Utah and Salt Lake Counties.

- viii. District Fourteen (14) is located in Beaver, Carbon, Emery, Grand, Iron, Juab, Millard, Sanpete, Sevier, and Utah Counties.
- e. **Local Boards of Education.** Members of the local boards of education should be elected as determined by individual school boards or districts.

3. JUDICIAL

- a. **Supreme Court.** There will be a retention election for one (1) Supreme Court Judge, provided that the incumbent whose term is expiring files during the filing period.
- b. **District Court.** There will be a retention election for twenty-four (24) District Court Judges in the following districts, provided that the incumbent(s) whose term is expiring files during the filing period:
 - i. First District. Two (2) Judges in the First Judicial District, which consists of Box Elder, Cache, and Rich Counties.
 - ii. Second District. Four (4) Judges in the Second Judicial District, which consists of Davis, Morgan, and Weber Counties.
 - iii. Third District. Fifteen (15) Judges in the Third Judicial District, which consists of Salt Lake, Summit, and Tooele Counties.
 - iv. Fifth District. One (1) Judge in the Fifth Judicial District, which consists of Beaver, Iron, and Washington Counties.
 - v. Eighth District. One (1) Judge in the Eighth Judicial District, which consists of Daggett, Duchesne, and Uintah Counties.
- c. **Juvenile Court.** There will be a retention election for ten (10) Juvenile Court Judges in the following districts, provided that the incumbent(s) whose term is expiring files during the filing period:
 - i. Second District. One (1) Judge in the Second Judicial District, which consists of Davis, Morgan, and Weber Counties.
 - ii. Third District. One (1) Judge in the Third Judicial District, which consists of Salt Lake, Summit, and Tooele Counties.
 - iii. Fourth District. Three (3) Judges in the Fourth Judicial District, which consists of Juab, Millard, Utah, and Wasatch Counties.

- Fifth District. One (1) Judge in the Fifth Judicial District, which iv. consists of Beaver, Iron, and Washington Counties.
- Sixth District. One (1) Judge in the Sixth Judicial District, which V. consists of Garfield, Kane, Piute, Sanpete, Sevier, and Wayne Counties.
- vi. Eighth District. One (1) Judge in the Eighth Judicial District, which consists of Daggett, Duchesne, and Uintah Counties.
- d. Justice Court. Any Justice Court judge whose term is expiring shall be subject to an unopposed retention election in the county or counties in which the court to which the judge is appointed is located.

4. COUNTY

County offices up for election are to be determined by the county's form of government.
